➤ Third round is open only for the seats not filled/Vacant in 2<sup>nd</sup> round (Mentioned in Serial No. 2).

➤ **Candidates already allotted Seats in 1<sup>st</sup> and 2<sup>nd</sup> Round:**

The Candidates who have been allotted seat in the first and second round shall have a right to retain already allotted seat. Opted seat shall be changed only if he/she gets an updated and opted seat during third round. However, the candidates who wish to participate in the 3<sup>rd</sup> round of online counselling will have to submit their preferences afresh again. Candidates, who have been allotted, seat in first and second round should give the fresh choices in order of preferences for the course/institute in which they wish to upgrade themselves.

If the candidates get a better seat in 3<sup>rd</sup> round, the seat allotted to him/her in first and second round will be cancelled and the candidate will have to accept the "upgraded" seat. In any case, such "upgrade" candidate will not be allowed to retain the seat allotted in first and second round. Therefore, the candidate must take great care in choice filling for "upgrade".

➤ **Already applied/Registered Candidates:**

Candidates who have already applied/Registered, need not reapply or pay additional fees for the 3<sup>rd</sup> round; However, they will be given option for upgradation of choices for courses.

➤ **Candidates who are applying Fresh/New registration:**

In 3<sup>rd</sup> round candidates are instructed to go through the prospectus and other information available for the seats mentioned in Serial No. 2 only.
