Certificate showing that the applicant has continuously studied from Class 8th to 12th in any recognized school located in the territory of Dadra and Nagar Haveli and Daman and Diu, as the case may be, issued by the Principal/ Head Master of the respective school.


		Note: "Applicants from the different districts in UT of DNH & DD, who have studied from class 1st to 10th in the respective district in UT of DNH & DD and due to non-availability of 11th & 12th classes in the concerned board/stream in the respective district in UT of DNH & DD, will only be given relaxation in the above criteria. The students will have to produce a certificate for non-availability of Class 11th & 12th from the Assistant Director of Education of the respective district in UT of DNH & DD"
4	For Scheduled Caste (SC)/Scheduled Tribe (ST) Candidates	a. Caste Certificate for SC/ST in prescribed format from the competent authority of Dadra and Nagar Haveli and Daman and Diu, as the case maybe.
5	For Other Backward Class Candidates	a. Caste Certificate for OBC in prescribed format from the competent authority of Dadra and Nagar Haveli and Daman and Diu, as the case maybe. b. Non-Creamy Layer certificate in case of applicant belonging to OBC issued by competent authority of Dadra and Nagar Haveli and Daman and Diu as the case may be after 31st March of the current year.
6	For Economically Weaker Section Candidates	a. Economically Weaker Section (EWS) certificate issued by competent authority of Dadra and Nagar Haveli and Daman and Diu, as the case may be after 31st March of the current year , for candidates applying under EWS category.
7	For Dependent Candidates	a. Dependent Certificate issued by the competent authority of Dadra and Nagar Haveli and Daman and Diu, as the case may be, in case of those who are claiming guardianship of the applicant.
8	For Person with Disability Candidates	a. Disability Certificate from Disability Assessment Board of Dadra and Nagar Haveli and Daman and Diu, as the case may be after 31st March of the current year , in case of differently abled candidates
9	First Priority	Applicants whose parents/guardians (in case Father and Mother are not alive) are Domicile of the UT of Dadra and Nagar Haveli & Daman and Diu and the applicant has studied continuously from Class 8 th to 12 th in any of the recognized school of this UT.

10	Second Priority	If the seats remain vacant after allotment of seats to candidates belonging to the first priority, then the applicant(s) whose parents/ guardian (in case Father and Mother are not alive) are Domicile of UT of Dadra and Nagar Haveli & Daman and Diu and candidates have studied in any recognized educational institution.
11	Third Priority	If the seats remain vacant even after allotment of seats to candidates falling in first and second priority, they will be offered to an applicant(s) whose parents/guardian (in case Father and Mother are not alive) are employees (regular/on deputation/on transfer) of the UT Administration/Central Government/UT PSUs/Central PSUs/ Nationalized Bank/Cooperative Bank and are posted in UT of Dadra and Nagar Haveli & Daman and Diu continuously for the past 5 years as on the last date of application and the applicants have studied in a recognized school of UT of Dadra and Nagar Haveli & Daman and Diu continuously from class 10 th to 12 th standard. In case of Bank Employee, their Headquarter shall be UT of Dadra and Nagar Haveli & Daman and Diu.
12	Fourth Priority	If the seats even remain vacant after allotment of seats to candidates falling in the First, Second and Third priority, then all the other eligible applicants will be considered in Fourth Priority.

Note: Seats reserved for SC/ST/OBC/EWS/PWD candidates in Dadra & Nagar Haveli and Daman & Diu will be filled up only by candidates of the UT of Dadra and Nagar Haveli & Daman & Diu who are entitled to such reservations. Candidates who or their parents have migrated from other states to UT of Dadra and Nagar Haveli and Daman & Diu shall not be entitled to avail benefits of these seats.
