Eligibility Criteria for Round 3 candidates

1. Fresh Registration with payment of registration fee for Round-3 Candidates:
 - who have not registered in Round-1 or Round 2.
 - who have registered but were not allotted a seat in Round-1 & Round-2 need not register again.
2. Candidates are informed that they will be shown in two categories during Round 3, which are as follows:
 - a) **Clear-cut vacancies**- The seats which have not been allotted after the Round 2.
 - b) **Virtual Vacancies**- Any Candidate who has been allotted a seat in Round 1 or Round 2 and has opted for up- gradation in Round 3, the allotted seats of Round 1 or Round 2 will be shown as virtual vacancy in Round 3 and Candidates can fill the said seat during the choice filling in Round 3. However, such seats will be allotted in Round 3 if the allottee of Round 1 or Round 2 vacates/upgrades in Round 3
3. Exercising of Fresh Choice filling and locking of choices
4. Publication of result of third Round on <https://namomeriadmission.in/>.
5. Physical Reporting at NAMO Medical Education and Research Institute, Silvassa after third Round with original documents.
 - i. If upgraded, the candidate must take relieving from Round 2 seat and join Round 3 seat. Once joined, he cannot upgrade or resign from this third-round seat.
 - ii. If any candidate does not join Round 3 seat, he may exit with forfeiture of security deposit and elimination (cannot participate in further rounds of counselling conducted by U.T. Administration of DNH & DD).
 - iii. If a candidate freshly registers in round 3 and is not allotted any seat, he/she is eligible to participate in stray/further rounds.
 - iv. Candidates getting upgraded in Round 3 shall not have any claim on earlier round allotted seat
